4 FIRST-AID MEASURES

GENERAL INFORMATION

Remove affected person from source of contamination. Perform artificial respiration if breathing has stopped.

NOTES TO THE PHYSICIAN

No specific first aid measures noted.

INHALATION

Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

INGESTION

If necessary, rinse mouth and provide fresh air. Get medical attention if any discomfort continues.

SKIN CONTACT

If necessary remove contaminated clothing and wash skin with soap and water. Get medical attention if any discomfort continues.

EYE CONTACT

Immediately flush with plenty of water for up to 15 minutes. Remove any contact lenses and open eyes wide apart. Get medical attention if any discomfort continues.

5 FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA

Fire can be extinguished using: Foam, carbon dioxide or dry powder.

SPECIAL FIRE FIGHTING PROCEDURES

Containers close to fire should be removed immediately or cooled with water.

UNUSUAL FIRE & EXPLOSION HAZARDS

No unusual fire or explosion hazards noted.

SPECIFIC HAZARDS

When heated and in case of fire, toxic vapours/gases may be formed.

PROTECTIVE MEASURES IN FIRE

Self contained breathing apparatus and full protective clothing must be worn in case of fire.

6 ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS

Use protective gloves, goggles and suitable protective clothing. In case of spills, beware of slippery floors and surfaces.

ENVIRONMENTAL PRECAUTIONS

Do not discharge into drains, water courses or onto the ground.

SPILL CLEAN UP METHODS

Absorb with inert, damp, non-combustible material, then flush area with water. Shovel into dry containers. Cover and move the containers. Flush the area with water.

USAGE PRECAUTIONS

Avoid spilling, skin and eye contact. Ensure adequate ventilation of the working area. Adopt best manual handling considerations when handling, carrying and dispensing.

STORAGE PRECAUTIONS

Store in tightly closed original container in a dry, cool and well-ventilated place. Keep away from heat, sparks and open flame. Protect from freezing and direct sunlight.

ENGINEERING MEASURES

Provide adequate ventilation.
