1 - Identification of Product and Supplier

Product Name: Thyme Oil, Red
Supplier: The Soap Kitchen (2011) Ltd

2 - Composition and information on ingredients:

INCI name: Thymus Vulgaris (Thyme) Oil
Definition/Botanical Origin: Thymus Vulgaris Oil is the volatile oil obtained from the flowers and leaves of the thyme, *Thymus vulgaris*, Labiatae.
CAS No: 8007-46-3
EINECS-CAS No: N/A
Application: Tonic/masking

3 - Hazards identification:

Xn - Harmful; N - Dangerous for the environment, C - Corrosive

4 - First aid measures:

Inhalation: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.
Eye contact: Rinse immediately with plenty of water for at least 15 minutes. Contact a doctor if symptoms persist.
Skin contact: Remove contaminated clothes. Wash thoroughly with soap & water, flush with plenty of water. If irritation persists, seek medical advice.
Ingestion: Rinse mouth out with water. Seek medical advice **immediately**.
Other: When assessing action take Risk & Safety Phrases into account (Section 15)

5 - Fire - Fighting measures:

Extinguishing media Use CO₂, Dry Powder or Foam type Extinguishers, spraying recommended: extinguishing media to base of flames. Do not use direct water jet on burning material.
Special measures: Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.
Extinguishing procedures: Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

6 - Accidental release measures:

Personal precautions: Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillages.
Environment precautions: Keep away from drains, soils, surface & ground waters.

<u>Cleaning up methods</u>	Remove all potential ignition sources. Contain spilled material.
<u>Cover for spillages:</u>	With an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.

7 - Handling and storage:

<u>Precautions in handling:</u>	Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene, and do not eat, drink or smoke whilst handling.
<u>Storage conditions:</u>	Store in tightly closed original container, in a cool, dry & ventilated area away from heat sources & protected from light. Keep air contact to a minimum.
<u>Fire protection:</u>	Keep away from ignition sources & naked flames. Take precautions to avoid static discharges in working area.

8 - Exposure controls and personal protection:

<u>Respiratory protection:</u>	Avoid breathing product vapour. Apply local ventilation where possible.
<u>Ventilation:</u>	Ensure good ventilation of working area.
<u>Hand protection:</u>	Avoid all skin contact. Use chemically resistant gloves if required.
<u>Eye protection:</u>	Use safety glasses.
<u>Work/Hygiene practices:</u>	Wash hands with soap & water after handling.

9 - Physical data and chemical properties:

<u>Colour:</u>	Colourless to yellow
<u>Appearance:</u>	Clear mobile liquid
<u>Odour:</u>	Characteristic, spicy-phenolic
<u>Flash point (°C):</u>	56
<u>Specific Gravity @ 20°C:</u>	0.880 - 0.939
<u>Refractive Index @ 20°C:</u>	1.485 - 1.507

10 - Stability and Reactivity:

<u>Reactivity:</u>	It presents no significant reactivity hazards, by itself or in contact with water. Avoid contact with strong acids, alkali or oxidising agents.
<u>Decomposition:</u>	Liable to cause smoke & acrid fumes during combustion: carbon monoxide, carbon dioxide & other non-identified organic compounds may be formed.

11 - Toxicological information:

Non toxic product if used in correct dosages – always dilute for skin or personal care. Skin patch testing is recommended for the final product.

12 - Ecological information:

Avoid spillage in environment – If spilt follow clear up procedures in line with Government environmental legislation – call emergency services if large spillage. Prevent surface contamination of soil, ground & surface water.

Toxic to aquatic organisms. May cause long-term adverse effects in the aquatic environment.

13 - Disposal considerations:

<u>Residue for disposal:</u>	According to local Government environmental regulations.
<u>Waste packing:</u>	Observe local regulations.
Avoid disposing to drainage systems and into the environment – seek expert advice.	

14 - Transport information:

Class 3 (8) hazardous liquid, UN 2924, packing group 3, see section 15. Will require Trem Card for transportation.

15 - Regulatory information:

Classified as Flammable liquid and Corrosive, flashpoint: $\approx 55^{\circ}\text{C}$ – keep away from sources of ignition.

Harmful, avoid contact with the skin and eyes – wear protective equipment. May cause lung damage if swallowed. If swallowed do not induce vomiting, seek medical advice immediately and show the container or label.

Toxic to aquatic organisms. May cause long-term adverse effects in aquatic environment.

16 - Other information:

Cosmetics directive 7th amendment: Restrictions may apply. A source of Limonene and Linalool, listed as sensitisers. Check maximum usage levels for skincare.

SHELF LIFE

When stored within advised conditions, re-test after 12 months then at 3 monthly intervals up to a maximum shelf life of 36 months.
