DEFINITION/BOTANICAL ORIGIN: Hydro-alcoholic extract of fresh strawberries (*Fragaria vesca*) in the ratio of 1 part fruit to 5 parts extractant.

3. HAZARDS IDENTIFICATION:

4. FIRST-AID MEASURES:

INHALATION: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

5. FIRE FIGHTING MEASURES.

EXTINGUISHING MEDIA RECOMMENDED: Use CO₂, Dry Powder or Foam type Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

SPECIAL MEASURES: Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.

PERSONAL PRECAUTIONS:	Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillages.
ENVIRONMENT PRECAUTIONS:	Keep away from drains, soils, surface & groundwaters.
CLEANING UP METHODS FOR SPILLAGES:	Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.
