4. First-aid measures

Inhalation : Remove from exposure site to fresh air, keep at rest, and obtain medical attention.
Eye exposure : Flush immediately with water for at least 15 minutes. Contact physician if symptoms persist.
Skin exposure : Remove contaminated clothes. Wash thoroughly with soap and water. Contact physician if irritation persists.
Ingestion : Rinse mouth with water and obtain medical attention.
Others : Take Risk and Safety phrases (section 15) into consideration.

5. Fire-fighting measures

Extinguishing media : Carbon dioxide, dry chemical, foam.
Do not use a direct water-jet on burning material.

6. Accidental release measures

Personal precautions : Avoid inhalation and contact with skin and eyes. A self-contained breathing apparatus is recommended in case of a major spill.
Spillage : Remove ignition sources. Provide adequate ventilation. Avoid excessive inhalation of vapours. Gross spillage should be contained immediately by use of sand or inert powder and disposed of according to local regulations.
Environmental precautions : Keep away from drains, surface and ground water, and soil.

7. Handling and storage
