3. Hazards identification

General : When undiluted and not properly handled, can be irritating to the skin and eyes and upon inhalation.

#### 4. First-aid measures

-----

- Inhalation : Remove from exposure site to fresh air, keep at rest, and obtain medical attention.

- Skin exposure : Remove contaminated clothes. Wash thoroughly with soap and water. Contact physician if irritation persists.
- Ingestion : Rinse mouth with water and obtain medical attention.

#### 5. Fire-fighting measures

- Extinguishing media : Carbon dioxide, dry chemical, foam.  
Do not use a direct water-jet on burning material.

#### 6. Accidental release measures

- Personal precautions : Avoid inhalation and contact with skin and eyes. A self-contained breathing apparatus is recommended in case of a major spill.

- Storage : Store in a cool, dry and ventilated area away from heat sources and protected from light in tightly closed original containers. Avoid plastic and uncoated metal containers. Keep air contact to a minimum.
- Fire protection : Keep away from ignition sources and naked flame.
