4. First-aid measures

- Inhalation : Remove from exposure site to fresh air, keep at rest, and obtain medical attention.
- Eye exposure : Flush immediately with water for at least 15 minutes. Contact physician if symptoms persist.
- Skin exposure : Remove contaminated clothes. Wash thoroughly with soap and water. Contact physician if irritation persists.
- Ingestion : Rinse mouth with water and obtain medical attention.
- Others : Take Risk and Safety phrases (section 15) into consideration.

5. Fire-fighting measures

- Extinguishing media : Carbon dioxide, dry chemical, foam.
Do not use a direct water-jet on burning material.

6. Accidental release measures

- Personal precautions : Avoid inhalation and contact with skin and eyes. A self-contained breathing apparatus is recommended in case of a major spill.
